## Chair's Report

Joe Tetlich advised of his recent activities and meetings he participated in, presenting information related to the Board, co-management and the Harvest Management Plan. He attended the Bathurst Caribou Regional Gathering in Behchoko, NT on January 29-31. He also attended the funeral service for the late Steve Taylor in January.

## Administrative and Financial Report

The Executive Director provided an administrative and financial report. The variance report was reviewed.

- Significant focus working on AHM planning.
- An MOU was drafted outlining the understanding between the PCMB and the Yukon Fish and Wildlife Management Board regarding proposing regulatory changes to the *Wildlife Act*. YFWMB reviewed the draft document and provided comments. PCMB members will review the draft and provide comments.
- A draft brochure "Dempster Best Practices for Caribou Hunters on Snow-machines" was distributed for review and comment.

## **Peel Watershed Plan**

The Board has been invited to provide comments on the Peel Watershed Plan that is currently out for public consultation by the Government of Yukon. The deadline for comment is February 25, 2013. The Board reviewed the draft response distributed and finalized its submission.

## **Hunter Education Package**

A draft Hunter Education Package was provided to members for review and comment. It will be finalized by Mike Sutor in the coming weeks and a contractor will be hired to lay it out, after which it will be brought back to the Board for feedback.

## **Dempster Regulations**

The draft Dempster Highway regulatory recommendations letter was reviewed and amended, as discussed. The final recommendations will be sent to the territorial government Ministers, copies to all other Parties.

## **Harvest Management Plan**

On December 21 Parties and stakeholders were sent an invitation letter and background information regarding the Annual Harvest Meeting scheduled for February 12-14, 2013 in Inuvik.

The Board reviewed the process and expectations for the AHM. Following the meeting, the Board will have 30 days to prepare and distribute its HMP recommendations to the Parties.

The Board approved the layout of the harvest data report as presented by Dorothy Cooley.

## **Strategic Framework**

The Board sent letters to all stakeholders acknowledging their feedback on the Strategic Framework (SF). The draft SF was sent to stakeholders for review and comment by December 15, 2012. The Board will review the comments received and finalize the Strategic Framework at its next meeting.

## **Next Meeting and Closing Prayer**

The next PCMB meeting will be held in Whitehorse on March 4, 2013 for one day.

The meeting was adjourned at 5:00 p.m. and a closing prayer was offered by Joe Tetlich.
